Agreement Concerning Pre trial Diversion


The State of Florida, through its assigned State Attorney and the Defendant, personally and through counsel hereby agree to the following regarding the disposition of the above styled cause.


The State of Florida will dismiss the indictment filed in the above styled case.


While Mr. Dyer disagrees with the interpretation of Florida Statute 104.047 taken by prosecution in this case which is set forth in a separate letter, he voluntarily agrees that he and any of his future election campaigns will abide by the state's interpretation until there is a definitive Court ruling or legislative clarification of the matter.


John Dyer, Jr, agrees not to seek reimbursement from the State of Florida or Orange County, Florida for his costs and fees. John Dyer, Jr, agrees to reimburse the Florida Department of Law Enforcement the sum of \$500 for a portion of the investigative costs expended in this case.
